AFFIDAVIT

I Pete DeRosa, hereby state the following under the penalties of perjury.

1. My name is Pete DeRosa and I reside at 8614 W. Varricchio Ln. Crystal River FL 34428  
and

2. I, Peter A DeRosa first meet Ms. Angela Hudson on a dinosaur dig in Northwest Colorado in May of 2001. At the dig Ms. Hudson's family became acquainted with my family. She found out we were from Florida and was interested and having some follow up relationship in Florida to get her boy's scuba diving lessons. So, she drove to Crystal River, Florida in her Hummer truck on 7-29-01 and departed either 8-6-01 or 8-7-03 from Orlando airport. She left her Hummer truck in Orlando to be work on. On 8-1-01 Ms. Angela R Hudson of Jeffersonville IN. was at my home. Ms. Hudson (without any solicitation by anybody in my family) asked if she could make a donation to our work in creation science. We were starting a organization called, Creation Expeditions which at that time was a sole proprietor with the purpose of teaching through educational, religious and scientific hands on adventures in creation science. She made the donation which was \$6000.00 check number 2086 date 8-1-01 at my home 8614 W Varricchio lane Crystal River Florida 34428. I told Ms. Hudson this money would be used as seed money to get the ministry work going. I told Ms. Hudson that we were not a non-profit and at this time but a sole proprietor and that if she need a tax right off to please keep her donation. She insisted that it would be okay and proceed with the donation. I have a affidavit by David W. Mittelstadt which put Ms. Hudson in my home on the night of 8-1-01. On 8-10-01 her check bounced and came back on my statement as a charge back, a copy of the statement is included. On 8-13-01 she wire transferred the funds to Florida. When she came to Crystal River for the dive lessons she paid me personal by check in the amount of \$1000.00 check number 2085 for the boy's dive lessons and any other items that they may need while on the trip. Check number 2091 for \$1000.00 was paid in Florida for damages to our back room floor that her dog chewed thru while visiting us in Florida. I have enclosed a copy of a receipt from The home Depot for the replacement of the flooring. Mid August she called and asked if we would pickup her Hummer in Orlando Florida and drive it to her in Jeffersonville, IN. also stating the dealer needed to be paid \$200 in cash for having her Hummer detailed. My son Peter DeRosa drove the Hummer with us following in our RV to Jeffersonville, IN. as we were going to a conference in Kentucky. We stopped in Jeffersonville for 4 hrs. and I gave her all the receipts for the fuel and detail job. She reimbursed us for our incurred expenses this was check number 2024 for \$1000.00. On 1-25-02 Ms. Hudson and family came to Crystal River Florida for a Manatee Encounter swim this is my home town. Again Ms. Hudson gave me a check number 2223 for \$1000.00 to pay for her family expenses for the swim and for staying at our home, we did not ask for these payments she insisted on helping with the expenses. I have a affidavit that puts Ms. Hudson here in Florida the date she wrote this check which was submitted by Dan Burns, enclosed. The last check on her register number 2288 amount of \$925.83 was a reimbursement for dive equipment she tried to purchase in Orlando Florida at Diver Outlet on 3-21-02. The store would not accept her credit card for the equipment for her sons, so I charged it on my card date 3-21-02 Re: 8041734FJLTLXRL7 in the amount of \$853.83 plus some other charges that night I have enclosed the equipment receipt. Present was my family and the Hudson family.

On 10-13-02 at the home of Doug Phillips 200 Canada Verde San Antonio TX. Ms. Hudson and family attend a worship service. After the service I spoke to her about the needs of the work to complete the restoration of the skull of our Allosaur dinosaur that we uncovered in Colorado. Ms. Hudson agreed to help and wrote a check in the amount of \$6000.00 Check Date 10-13-02 number 2578. This all happened at the home of Mr. Doug Phillips in San Antonio TX. At that time we were a 501(c)(3) and incorporated under IRS laws. I sent Ms. Hudson a receipt of her donation on November 6, 2002 I have enclosed a copy of the letter of receipt with the file. I never heard anything else about this matter until this suit appeared. We have other affidavits to verify Ms. Hudson in San Antonio on this date and that it did not take place in Jeffersonville IN.

I declare I am a Christian and therefore submit to the authority of the Holy Bible. I also declare Ms. Hudson on several occasions has declared to be a Christian.

I AFFIRM UNDER THE PENALTIES OF PERJURY THAT THE ABOVE MENTIONED STATEMENTS ARE TRUE TO THE BEST OF MY KNOWLEDGE.
