

Contract Dragons Den Dinosaur Dig

Agreement made this: ____ day of _____ 2002, Between Peter & Linda DeRosa D/B/A Creation Expeditions, and Dana & Brenda Forbes.

Location: _____

Length of Agreement: Six years starting May 1, 2002 ending May 1, 2008

Terms of the Agreement:

1. Sites: Will be determined by Creation Expeditions and Dana Forbes. Said sites will be marked on a plat map and of which photos will be taken. Creation Expeditions and Dana Forbes will sign off in agreement to said sites. No other excavation may take place on said sites without permission of Creation Expeditions. Creation Expeditions will have the rights to all materials on said sites in accordance with this agreement. Creation Expeditions will have access to said sites at all time to do excavation on material on sites, no fees will be paid to the Forbes when just excavation is taking place without a organized tour.
2. Royalties: All materials from sites that are devolved by Creation Expeditions will be paid as follows, Dana & Brenda Forbes 15% of the gross sale price, Creation Expeditions 85% of the gross sale price. The sale price will be determined by having two appraisal done of the material and taking the highest one or best offer.
3. Tours: Creation Expeditions will have rights to determine dates for tours and have the opportunity to have as many as six tours per year. Creation Expeditions will have full control of tours on site and will plan all details for groups to visit with pre-approval from Dana Forbes. During tours (which will include excavation, restoration and other activities), Creation Expeditions will have sole access to the property. Creation Expeditions will have exclusivity to all dig sites that they develop on said property and no other excavation may take place on said sites without permission of Creation Expeditions. All materials that are removed will be jointly owned by Creation Expeditions at 85% and Dana & Brenda Forbes at 15%. Dana & Brenda Forbes will receive a payment for each tour as defined here after: 20 people or more \$1500.00; 11 to 20 the payment will be \$1000.00; 9 or less \$500.00. No materials may be taken by any persons on said tours without permission of the Forbes outside of the dig sites. Dana & Brenda Forbes give permission for Creation Expeditions to use the property for work crew to camp. Also, to set up tent areas to feed participants on the tours. Creation Expeditions will pay fees for Port-a-Pot at site when tours are taking place.
4. Materials: All excavations, restoration, and costs involved for the removal of fossils will be provided by Creation Expeditions on Creation Expeditions approved sites.
